Business operations will be maintained in full. Aircraft Products and Services GmbH to support the company. The lawyer and restructuring expert Dirk Obermüller from dhpg in Bonn has been appointed as provisional trustee by the competent insolvency court.

The worldwide corona pandemic and the reduced volume of air traffic led to a negative market situation and considerable losses in turnover. The restructuring concept pursued by the self-governing body is now to be implemented on the basis of an insolvency plan. "Major customers have already indicated that they will support the intended restructuring," said Dr Bornheimer. The aim is to consolidate E.I.S. and make it fit for the future.
